This product is for postharvest application to freshly washed apples. Apply one gallon to 8,000 - 10,000 pounds (1 liter per 1,000 kg) of apples by spraying onto the apples on a brush bed or other suitable applicator. Higher poundage of fruits can be treated on certain cultivars such as McIntosh, Golden Delicious, and Granny Smith. For best results, clean fruit with an appropriate Decco cleaner prior to application of **APL-Lustr® 221**.

CAUTION: Condensation may form on apples following their removal from cold storage or for other reasons related to the manner in which they are stored, handled, processed, or packed. Subsequent evaporation of the moisture may cause white spotting of the fruit coating.
