DIRECTIONS FOR USE:

Mix well before use.

For Peach, Nectarine & Plums: Apply one gallon of undiluted product to 30,000-35,000 lbs of peaches, nectarines or plums. Use one gallon of 1+1, 1+2 or 1+3 (soft water) diluted product on 18,000, 12,000 or 9,000 lb of fruit respectively. Apply by spraying on rollers or on brushes. If used with fungicides, select the best dilution rate for sufficient and uniform wax coverage without violating the fungicide label. Keep fungicide mixture agitated during application.

For Cherries: Dilute the product with 9 parts of soft water. Apply 1 gallon of diluted product by spraying onto 4,000-5,000 lb of cherries in a non-recovery system. Do not over apply. Remove the excess liquid in case of over application by using a blower.

For Mangos:

Dilute the product with 3 parts of soft water. Apply 1 gallon of diluted product by spraying onto 10,000 to 12,000 pounds of clean damp mangos in a non-recovery system. For dip applications dilute the product with 9 parts of water. Dip mangos for 10-15 seconds and air dry.

For Other Crops: Call your Decco Representative. Do not use on apricots.
