Chrismas trees

Treat as soon as deficiencies appear, if no leaf or soil analysis are available, apply 5L/ha in enough water to provide good coverage. Repeat if deficiency is still showing.

Field crops

Treat with recommended rates before the crop has reached a third of its growth.

Fruit trees, small fruit and blueberries

Treat as soon as deficiencies appear, if no leaf or soil analysis are available, apply 2.5L/ha in enough water to provide good coverage. Repeat if deficiency is still showing.

Lawn and turf

Make 1 to 4 treatments per season with this product at the rate of 0.10 litre per 100 m². Vegetables

If leaf or soil analysis are not available, apply 2.5L/ha as soon as deficiencies are noticed or before the crop has reached a third of its growth and repeat if deficiency is still showing.
