Re: Mako Insecticide (Reg. No. 30316, 407 g cypermethrin/L) for emergency registration to suppress spotted wing drosophila on stone fruit (12-09), caneberry subgroup (13-07A), small fruit vine climbing subgroup, except fuzzy kiwifruit (13-07F), and low growing berry subgroup, excluding lowbush blueberry (13-07G) in British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, Quebec, New Brunswick, Nova Scotia, Prince Edward Island and Newfoundland and Labrador

Your application to amend the registration of Mako Insecticide for the emergency suppression of spotted wing drosophila in stone fruit (12-09) and berry crop subgroups 13-07A, F (except fuzzy kiwifruit), and G (excluding lowbush blueberry) in British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, Quebec, New Brunswick, Nova Scotia, Prince Edward Island and Newfoundland and Labrador has been granted. Pursuant to section 18 of the *Pest Control Product Regulations* the amendment is granted for a validity period beginning June 1, 2017 and ending November 30, 2017 subject to the following conditions:

- Label changes must be made according to the attached annotated supplemental label.
- For enforcement purposes, residues in/on stone fruit (12-09) and berries (13-07A, F, G) treated as a result of the emergency registration of Mako Insecticide for the suppression of spotted wing drosophila may be up to:

Crop Group/Crop Subgroup	MRL (ppm)
Small fruit vine climbing (except fuzzy kiwifruit) 13-07F	0.5
Stone fruits 12-09;	0.2
Low growing berry (except lowbush blueberry) 13-07G	
Caneberry 13-07A	0.1

and that these residues do not pose an unacceptable risk to the consumer including infants, children, adults and seniors.



• The Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) must inform Engage Agro Corporation should OMAFRA become aware of any incident that occurs as a result of the use of Mako Insecticide for the emergency suppression of spotted wing drosophila in stone fruit (12-09) and berries (13-07 A, F and G) in British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, Quebec, New Brunswick, Nova Scotia, Prince Edward Island or Newfoundland and Labrador. The PMRA urges the sponsor to coordinate efforts with Agriculture and Agri-Food Canada and the registrant to seek registration of these uses through the regular submission process. Consideration of future emergency registration applications for these uses will be contingent upon receipt of a letter from the sponsor outlining concrete steps that have been taken towards registration, including a projected timeline.
