DIRECTIONS FOR USE:

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

WHEN TO APPLY: Early morning or evening is the best time to apply the bait, as slugs and snails travel and feed mostly by night or early morning. Re-apply as the bait is consumed or at 14-day intervals if slugs and snails continue to be a problem.

WHERE TO APPLY: All likely areas of infestation (i.e., damp places) should be treated. Also treat around the perimeter of crop areas to intercept any slugs or snails travelling into these areas from daytime refuge sites. Slugs and snails favor damp places around and within vegetable crops, in and around weeds or ditches around field margins, and leafy herbaceous perennials. Although phytotoxicity is not expected, it is recommended that a small group of test plants or small area be treated with Safer's Slug & Snail Bait II before treating an entire crop.

HOW TO APPLY: Safer's Slug & Snail Bait II is to be applied evenly on the soil surface around or near plants and areas to be protected. Do not place bait in piles. The soil should be moist, but with little or no standing water. Product can be applied using ground equipment such as a handheld spreader or rotary type spreader. Use the higher rates to control slugs and snails at higher levels of pest pressure.

Crops/Use	Rate	Directions
Vegetables	11-22 kg/ha	Evenly scatter the bait around the perimeter of vegetables and between rows where slugs or snails are observed.
Orchard fruits	11-22 kg/ha	For mature trees in orchards, evenly scatter bait evenly around the base of the trees where slugs or snails are observed. For new seedlings, spread bait evenly in a 15 cm band around the base of the stem where slugs or snails are observed.
Berries	11-22 kg/ha	Evenly scatter by hand or with granular spreaders around the perimeter of plot and between rows where slugs and snails are observed. For small plots, evenly apply the bait around the base of the plants to be protected from slugs and snails. Do not broadcast entire area, but treat selectively.
Field crops	11-22 kg/ha	At all stages of growth, evenly apply the bait between the rows and around the field perimeter where slugs or snails are observed.
Vineyards	11-22 kg/ha	Evenly scatter bait at the base of vines and between rows where slugs or snails are observed.
Wheat	11-22 kg/ha	Evenly scatter bait with a granular spreader in areas where slugs or snails are observed.
Grass grown for seed production	11-22 kg/ha	Evenly scatter bait with a granular spreader in areas where slugs or snails are observed.

APPLICATION RATES

(turf and feed crops)		
Greenhouse vegetables	2 g/m ² or 1 g/ 10 pots measuring 23 cm diameters	Evenly scatter bait on the soil surface of potted plants being damaged by slugs or snails. Bait can also be evenly scattered around pots on greenhouse benches.
Greenhouse ornamentals	2 g/m ² or 1 g/ 10 pots measuring 23 cm diameters	For large areas, evenly scatter bait on the soil surface of potted plants being damaged by slugs or snails. Bait may also be evenly scattered around pots on greenhouse benches.
Outdoor ornamentals	2 g/m ²	Evenly scatter bait in a 15 cm wide circular band around the base of the plants to be protected where slugs or snails are observed.
Outdoor container-grown nursery plants	2 g/m ² or 3 g/ 10 pots measuring 46 cm diameters	Evenly scatter bait on the soil surface of containers where slugs or snails are observed. Bait may also be evenly scattered on the soil surface around pots.
Turf, golf courses, sod farms	2 g/m ²	Evenly scatter bait with a granular spreader in areas where slugs or snails are observed.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take the affected person to a safe and uncontaminated area. Seek medical attention IMMEDIATELY if redness, swelling, itching, burning or shortness of breath occurs. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

ENVIRONMENTAL HAZARDS: Do not apply directly to water.

DISPOSAL
