DIRECTION FOR USE:

Equipment Cleaner 511 is a high foam alkaline cleaner for cleaning deposits from packing line, equipment, and facility.

For cleaning equipment: Flush equipment with water. Apply Cleaner 511 at dilution of 4 parts water to 1 part cleaner over surface to be cleaned such as belts, rollers or sizers. Let soak until deposits becomes soft; applying additional Cleaner 511 solutions as needed. Hose off with a strong stream of water. Perform cleaning on regular basis to maintain equipment free of deposits. Use hot water where available to speed up cleaning time.

For cleaning brushes: Dilute 1 part Cleaner 511 with 9 parts water and soak brushes in solution until deposits are softened; about 2 hours. Hose off and rinse with a strong stream of fresh water. Use hot water to speed up cleaning.

For general cleaning: Dilute the Cleaner 511 with water as needed to effectively clean the area. Rinse off the cleaner completely with fresh water.

CONTENTS: Synthetic detergents and cleaning agents.
