DIRECTION FOR USE:

Equipment Cleaner 510 is an alkaline cleaner for cleaning deposits from packing line and equipment.

Flush equipment parts with water. Apply Equipment 510 at dilution of 4 parts water to 1 part cleaner over surface to be clean such as belts, rollers or sizers. Let soak until wax becomes soft applying additional Equipment Cleaner 510 solutions as needed. Hose off with a strong stream of water. Perform cleaning on regular basis to maintain equipment free of deposits.

Use hot water where available to speed up cleaning time.

For brushes, soak in a solution of 1 part cleaner 510 to 9 part water. Let set approximately 2 hours or until wax softens. Hose off with a strong stream of water.

CONTENTS: Synthetic detergents and cleaning agents.
