4. First-Aid Measures

Description of first aid measures

General advice:

6. Accidental release measures

Further accidental release measures:

Dust in sufficient concentration can result in an explosive mixture in air. Handle to minimize dusting and eliminate open flame and other sources of ignition.

Personal precautions, protective equipment and emergency procedures

Environmental precautions

Methods and material for containment and cleaning up

Protect contents from the effects of light. Protect against heat. Protect from air. Handle and open container with care. Avoid aerosol formation. Avoid dust formation. Provide means for controlling leaks and spills. Do not return residues to the storage containers. The substance/ product may be handled only by appropriately trained personnel.
